



## Terms & Conditions

Your booking is made with Britton Outdoors, 22 Fuchsia Avenue, Caherdavin Heights, Limerick, Ireland

Britton Outdoors tours run with a **minimum** of seven clients. If Britton Outdoors has to cancel any trip, six weeks' notice will be given and all money will be refunded to the client. We reserve the right to refuse any booking if we consider it necessary.

If you are prevented from proceeding, you may transfer your booking to any other appropriate person free of charge, provided that you give reasonable notice before the departure date and that there are no other changes to the booking details.

The itinerary shown is a guideline only and may not, at times, be strictly adhered to. However, every reasonable effort has been made to fully describe the tours offered and every reasonable attempt will be made to honour what has been described.

The decisions made by the Britton Outdoors team relating to the aims and well-being of the group shall be final and accepted by all participants.

Any likeness of you secured or taken on any of our tours or any imagery/media which you capture and share with us (e.g. either by email or on social media), may be used by Britton Outdoors without charge in all media, for bona fide promotional or marketing purposes, including without limitation promotional materials of any kind, such as brochures or on the Internet.

In the interests of continuing to offer the best possible standards of service, Britton Outdoors reserves the right to share, or not to share, any feedback or comments received from you with our business partners be they accommodation suppliers, luggage transfer providers, taxi drivers, walking guides etc.

## Payment

The full package costs €1,100pp sharing. The **early bird price** of **€950pp** sharing is valid until the **31<sup>st</sup> July 2023**. The price includes packed lunches on the hiking days and two nights' dinner in the hotel. All other food and drinks are at your own expense. The cost excludes flights. It is your responsibility to get to the meeting points at the designated time.

A booking deposit of 30% (€330) is payable to confirm your booking.

A further 40% (€440) of the payment is due 8 weeks before the start date.

The balance of payment 30% (€330) is due 4 weeks prior to the start date. If you have booked in at the early bird price then your final payment will be €180

**Refund Policy**

In the unfortunate case that you need to cancel your trip with us we will work with you to try to get the best outcome. Our formal refund policy is as follows:

You can transfer your booking to any other appropriate person free of charge.

Cancellation a minimum of 8 weeks before tour start date: Britton Outdoors will retain the deposit and refund any additional payments that have been made.

Cancellation between 6 - 8 weeks from the tour start date: Britton Outdoors will refund you 50% of tour price

Cancellation between 4 - 6 weeks before tour start date: Britton Outdoors will refund you 20% of tour price

Cancellation less than 4 weeks before tour start date: No refund



### **Single Room Supplement**

Prices shown are for shared rooms. If you are travelling as a single person and would like a single room to yourself this can be arranged at a supplement of €125.

### **Travel Insurance**

Although we take the greatest care to ensure that everything runs smoothly on your trip please note that neither Britton Outdoors, its employees nor its agents can accept any liability relating to personal injury or illness, loss or damage to personal equipment, or any other unforeseen events that occur during your walking tour. All participants agree to fully release the Company and each of its officers, employees and contractors, from all liability arising from any claim you may have. All participants must be adequately insured and it is essential and compulsory to take out travel insurance. You are wholly responsible for arranging your own insurance and you should ensure that your policy will cover your costs in the event of you having to cancel your own tour.

Any information or advice provided by Britton Outdoors on matters such as walking routes, climate, clothing, travel documents, baggage, special equipment etc. is given in good faith but without responsibility on the part of the business.

If the tour is disrupted beyond the control of Britton Outdoors (eg force majeure), any additional expenses incurred through delay, disruption or accident shall be borne by the client.



### **Health and Medical Care**

General good health is required on a walking holiday. Any medical condition must be declared at the time of booking. Clients agree to accept the authority and decisions of the Britton Outdoors tour leaders and the Britton Outdoors suppliers whilst on the tour. If in the opinion of such persons the health, level of fitness or conduct of a client at any time before or after departure appears likely to compromise the safe, comfortable or happy progress of a tour the client may be excluded from all or part of the tour without refund or recompense.

Britton Outdoors advises you to bring your EHIC (European Health Insurance Card) and we also highly recommend taking out a Private Health Care insurance policy to give you access to both the private and Public health Care systems in Spain during your stay.

Any client / clients causing disruption, disturbance, damage or annoyance to other clients, leaders, property or third parties will be expelled from the tour with no refund. This includes any client who fails to advise us of a medical condition or disability which prevents their full participation in the tour.

Once your deposit has been received and you have signed the booking form, you have implied acceptance of the above conditions.
